ORDER ON MOTION FOR CONTEMPT

Plaintiff Tea Party Patriot's ("TPP") Motion for Contempt Hearing having come before this Court for oral hearing at 1:30 pm on May 4, 2011, the duly-noticed day and time, and all parties having received notice and appeared, the Court's having read and considered the pleadings and having reviewed the parties' presentation of argument and evidence on the matter, and with good cause being shown,

THE COURT HEREBY FINDS that the Defendant, AMY KREMER, is in contempt of this Court's order, dated December 9, 2009 and consented to by the parties ("Consent Order"), in two particulars:

- 1. Amy Kremer has not taken all necessary steps to deliver administrative control of websites, specifically the Google Groups accounts for Tea Party Patriots and Georgia Tea Party Patriots, to TPP. Consent Order ¶ 2.
- 2. Amy Kremer has used TPP's name in ways that imply current affiliation with TPP, including holding herself out as a founder of TPP without also stating equally prominently that she has no current affiliation with TPP.

WHEREFORE, DEFENDANT AMY KREMER IS HEREBY ORDERED

A. To immediately provide administrative control to TPP of the Google Groups accounts for Tea Party Patriots and Georgia Tea Party Patriots, and all other websites as

identified in the Consent Order, in a manner that allows TPP unfettered discretion regarding whom to include in and whom exclude from said groups;

B. To immediately remove herself from being listed in the aforesaid groups and websites; and

C. To correct the information that she has distributed to the public to reflect the fact that she has no current affiliation with TPP, including notifying all organizations listing her background or credentials to so amend all information in their files or distributed to the public. Defendant Amy Kremer is directed to take all necessary steps related to such correction within 20 days following the date of this order, and in the future as it is brought to her attention.

This order makes no finding about who is the legal owner of the Google Groups, or any other matter that is at issue in this trial. If TPP believes that Defendant Kremer has not complied with this order, it may seek a second hearing on this matter, and seek such relief as is appropriate.
